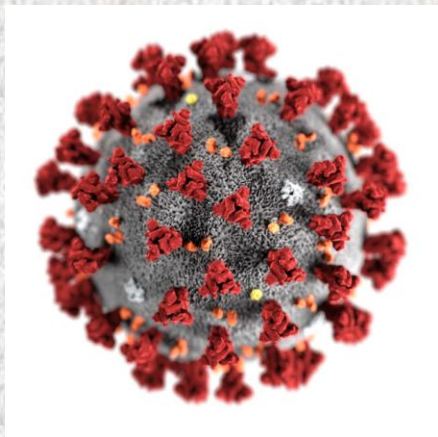

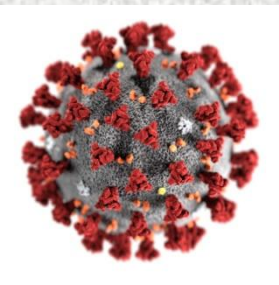


Topic 1: VACCINATION HESITANCY

Refers to:

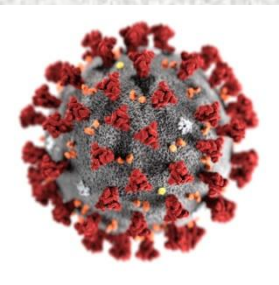
- *Delay in acceptance,*

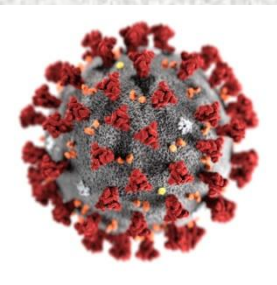

NOT VACCINATED

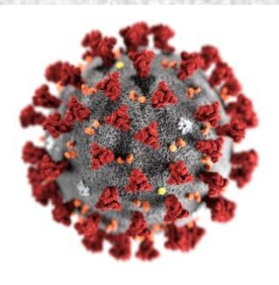


Topic 1: VACCINATION HESITANCY

- ✓ **Business Establishments that choose not to get vaccinated should get themselves tested once in every ten days**

(= Negative RT-PCR)



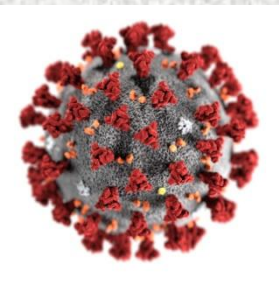

SHOPKEEPERS AT LAITKOR LUMHEH VILLAGE

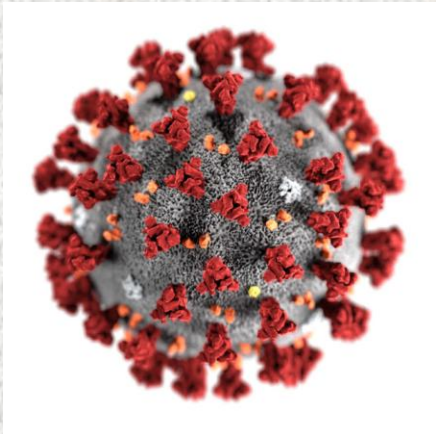
ISSUES:-

- ✓ *Refused to get vaccinated*
- ✓ *Refused to get tested after every 10 days*

- ✓ *Decided to go against the Orders of the Government*

Topic 2 - LAW & ORDER SITUATION

 - ❖ *Breach of peace and tranquility,*
 - ❖ *Disruption of normal life,*
 - ❖ *Violation of the law of the land,*
 - ❖ *Destruction of public property,*
 - ❖ *Violence*
 - ❖ *Etc.*

Requires Law Enforcers (Magistrates/Police) to act upon and ensure that Law & Order prevails.
