The soft copy of the Undertaking-cum-Declaration is available on the official website of MATI at: www.mati.gov.in. Candidates may download the prescribed Undertaking-cum-Declaration from the website, duly complete and sign the same, and submit it to the Office of MATI within the stipulated period.
- Candidates are hereby informed that failure to submit the duly completed Undertaking-cum-Declaration within the stipulated period of seven (7) working days shall be treated as unwillingness/non-acceptance to avail the sponsorship under the Programme, and the candidature of such candidate shall be liable to be treated as withdrawn.
- In such an event, the next eligible candidate in the order of merit/rank shall be considered for selection in place of the candidate who fails to submit the Undertaking-cum-Declaration within the prescribed period.
- No separate claim or request for extension of the stipulated period shall ordinarily be entertained.
